3. **Exclusion of Liability:** Except where provided or required by law and such cannot be excluded, I agree that it is a term of my membership (if accepted) that the Club is absolved from all liability however arising from any Claims arising out of my membership and/or participation in any Club Activity.
4. **Release and Indemnity:** In consideration of the Club accepting my application for membership I:
 - (a) release and forever discharge the Club from all Claims that I may have or may have had but for this release arising from or in connection with my membership and/or participation in any Club Activity; and
 - (b) indemnify and hold harmless the Club to the extent permitted by law in respect of any Claim by any person including but not only another member of the Club arising as a result of or in connection with my membership and/or participation in any Club Activity.

CODE OF CONDUCT

PLAYER'S CODE OF CONDUCT:

- Play by the rules – the rules of your club and the laws of the game.
- Never argue with an umpire or other official – without these people you can not play football
- Control your temper – verbal abuse of officials and sledging other players doesn't help you enjoy or win any games.
- Be a team player – It's a team game, treat it that way
- Treat all players as you would like to be treated – fairly
- Co-operate with your coach, the umpires and teammates.
- Play for your own enjoyment and to improve your skills
- Don't use ugly remarks based on race, religion, gender or ability – you'll let down your coach, teammates and family if you do and many such comments are actually now illegal.

PARENTS AND SUPPORTERS CODE OF CONDUCT:

- Remember that you are there for the participants to enjoy the game
- Encourage participation, but don't force it.
- Teach that enjoyment is more important than winning
- Never ridicule mistakes or losses – supporters are there to support not downgrade.
- Lead by example and respect all players, coaches, umpires and spectators – physical or verbal abuse will not be tolerated.
- Recognise all volunteers who are giving up their valuable time.
- Never publicly criticize umpires – raise personal concerns with club officials in private.
- Don't use ugly remarks based on race, religion, gender or ability – you'll let down your family and yourself if you do and many such comments are actually now illegal
